1. SCOPE AND LIMITATIONS:

- Use of refrigerator and kitchen area are allowed with prior authorization. All materials should be washed, dried and returned to their location . You may only use the counter space on the right hand side. Anything from the refrigerator to the left is HeadStart Program and is to be left along due to strict licensing and regulations.
- Any program materials needed will need to be brought in and taken out. This includes chart paper, and any of your printed materials.
